I. Brief biographical and professional data about the candidate's

development

Assoc. Dr. Zlatina Karadjova was born in the city of Burgas, where she graduated from secondary school (GRE «G.S. Rakovski») and higher education (University «Prof. Dr. Asen Zlatarov»). Defended a doctoral dissertation on the topic "The quality of the Bulgarian marine tourism product and its management (on the example of the Southern Black Sea coast)" in 2005, diploma N 30526, 29.05.2006, scientific commission 16, Protocol 5 of 14.03.2006. From the academic year 2008/In 2009, she was appointed to a basic employment contract after winning a competition for an assistant at the State University, she obtained her habilitation in 2012. In 2016 by order of the Rector, he became a member of the "Organization and Management of Health Care" department and of the Faculty Council of the Faculty of Public Health and Healthcare.

Zlatina Karadjova also works in the tourism system, skilfully combining her theoretical knowledge with practical skills. He is fluent in written and spoken French,

English and Russian. Currently, she is a licensed tour guide - inbound and outbound

tourism, registered in the national tourist register.

On 15.12.2023 the candidate has been elected as the head of the "Organization and Management of Health Care" department. Assoc. Dr. Zlatina Karadjova is a tutor of the "Tourism" and "Health Tourism" specialties, a member of the Quality Commission, a member of the UMS, a member of the FC of the FPHHC, deputy. chairman of the General Assembly of the Foundation, member of the General Assembly of the University «Prof. Dr. Asen Zlatarov», Burgas.

Zlatina Karadjova is on the control board of the Southeast Union of Tour Guides "Vanya Raykova", on the board of the Bulgarian Association for Climatotherapy and Health Tourism and a member of the Bulgarian Scientific Society for Public Health.

II. Evaluation of quantitative and qualitative indicators

Assocuate professor Zlatina Karadjova has presented a signed comprehensive material consisting of 63 scientific works, containing a copy and Internet addresses of the scientific works (articles and reports), monographs and a textbook in paper and electronic version, declarations of co-authorship, certificates for participation in national and international projects and trainings, as well as reference for noticed citations. The presented works contain the necessary information for quantitative and qualitative assessment of her overall academic development in the field and the issues of the competition - PD 7.4. "Public Health", scientific specialty "Health Tourism":

8. Participation in 4 international, 8 national and 4 internal university projects.

 Reference noticed citations - in scientific publications, referenced and indexed in world-famous databases with scientific information (Scopus), in nonrefereed journals with scientific review and in monographs.

10. Reference of her doctoral students enrolled in NACID who have

successfully defended their dissertation work.

Its scientific production exceeds four times the minimum national and those of the University «Prof. Dr. Asen Zlatarov» Burgas requirements. IV. Basic scientific and scientific-applied contributions

The contributions contained in the works submitted for participation in the competition can be summarized as follows:

1. The leading role of health tourism as a prospective direction for increasing the competitiveness of destination Bulgaria on the world/domestic and international tourist market/ is substantiated.

2. A target classification of the types of health tourism was formed, the profile

of the user of a health tourism service was presented.

3. Research is presented that reveals the socio-economic impact of the Covid 19 pandemic, the impact on people's motives for traveling and the possibilities for sustainable development of modern society through prevention, prevention and health-restorative procedures.

4. The participation of tour operators as providers of health-tourism services

(medical facilities, spa hotels and recreation centers) is confirmed.

5. The impact of terrorist and cyber attacks on tourism behavior is explored in the context of public health.

6. The leading role of quality as the main competitive advantage is proven. The criteria for the quality of services in health tourism are derived. The principles for developing a quality system in health tourism have been formulated, the main quality standards have been presented, a certification technology has been developed, and the benefit of implementing standards has been proven.

7. The opportunities for diversifying the Bulgarian tourist product and its sustainable development by enriching the product with alternative types of tourism

in the context of people's emotional and mental health are presented.

8. The relationship and dependence between opportunities for recreation and recovery of a person's physical and mental strength and his health is exposed.

9. The modern trends in the development of our society, the challenges facing the management of human resources as the basic capital of society and the impact of today's hectic everyday life on human health are examined. The connection and dependence between the quality of education, career development and quality of life is highlighted.

10. A new master's program "Health Tourism" was initiated in PN 7.4 "Public Health" from the Department "Organization and Management of Health Care", University "Prof. Dr. Asen Zlatarov» - Burgas, which is also inspired by business

requirements.

V. Educational - teaching activity

As can be seen from the attached curricula for the disciplines she teaches, her workload is on average one hundred (100) hours over the norm in OCS "Bachelor" and OCS "Master" with a norm of 400 hours.
