Dr. Iliya Dimitrov Popov was born on October 21, 1959.

He completed his secondary education in the town of Sandanski.

He completed his higher medical education at the Medical Academy - Sofia in 1985. The results from the study completion and from the state exams are good.

Specialty in internal diseases acquired in 1991, and specialty in nephrology - in 1995.

After the defense of the dissertation work on the topic "Participation of the infection with Helicobacter pylori in the gastric pathology in patients with CRF on hemodialysis", he acquired the scientific and educational degree "Doctor of Medicine" with a certificate from VAK 30658/10.07.2006 (day, month, year.) In 2016, after a competition, he has held the academic position "Associate Professor".

Research Activities:

The scientific research activity of Dr. Iliya Dimitrov Popov after his election as an Associate Professor includes:

- Dissertation work 1 piece;
- Monographs 2 pieces from 2019;
- Publications of scientific papers 31, some of which are in Bulgarian, and part of them in English;
- Publications and reports published in scientific journals, referenced and indexed in world-famous databases with scientific information (Scopus; Web of Science) mainly from 2018 and 2019 – 15 Pieces
- Publications and reports published in non-referenced journals with scientific review, or published in edited collective volumes mainly in 2017 – 2019, 16 pieces.
- · First author in 25% of the scientific articles;

- In the majority of articles, he is listed as the last author, probably as the head of the collective;
- 3 publications with IF 3.37; With IF 0.981 and IF 0.901;
- One of the publications is in cooperation with an international team.

Publications by Dr. Iliya Popov based on the data from his personal report are quoted by other authors over 20 times.

His overall impact factor for publications in foreign journals, according to the data, I have found for the above-mentioned three publications with impact factor is 5.26.

If the university that has announced the competition has adopted its own system for evaluating the impact factor, the criteria should be applied in order to make the appropriate restatement.

The research activity of Dr. Popov is versatile and covers a wide segment in the field of internal diseases. In addition to the field of nephrology, he has done research in the areas of gastroenterology, oncology, cardiology, hematology, and clinical laboratory. All of this corresponds to the logic of the competition.

There is a considerable scientific and publication stature after his election as an Associate professor. Special scientific growth is marked in the last 2 years-2018 and 2019.

Scientific developments can be grouped into five main scientific areas:

- It has been proven that a major role in the damage to the gastric mucosa is played by chronic endogenous intoxication, and the infection with Helicobacter pylori is superimposed on it;
- It has been proven that the treatment of the Helicobacter pylori infection is carried out with medical therapy in dosages and duration as in patients without kidney diseases with the corresponding adaptation;
- Part of the publications are clinical cases from the practice with educational and practical benefit in the field of internal diseases.
- Chronic kidney disease (CKD) leads to a number of complications and diseases and affects other organs and systems;
- Experimental nephrology for the study of proinflammatory activity
 of hemodialysis membranes in the framework of permanent
 replacement therapy of renal function.

Summary of the most important contributions of scientific works taking into account the self-assessment of the candidate;
