The Applicant has submitted all the documents necessary for the participation in the competition, in compliance with the requirements provided by the Act for the Development of the Academic Staff in the Republic of Bulgaria, the Regulation for its Implementation and the Rules on the Conditions and Procedure for Acquiring Science Degrees and Holding Academic Positions in Professor Doctor Asen Zlatarov University.

Concise biographical and professional data on Applicant's development

Chief Assistant Professor.Katya Eftimova Popova was born on October the 13th 1962

in the town of Burgas where she completed her Secondary education.

In 1980-1982 she completed her Secondary Medical education at *Doctor K. Vezenkov* INSTITUTE FOR PREPARATION OF HEALTH STAFF with SECONDARY SPECIALIZED EDUCATION – Burgas, Nursing Specialty – general profile; In 1995 – the Medical College Education (specialist) acquired at the College of Medicine in Burgas, Nursing Specialty – general profile. In 1987-1993 – Master Degree awarded at *Paisiy Hilendarski* College of Medicine in Plovdiv, Specialty in Biology and Chemistry, the teacher of Biology and Chemistry. In 2014-2016 - Master Degree awarded at the Medical University – Sofia, specialty in Healthcare Management. In 2015-2017 specialty in Medical Pedagogy acquired at the Medical University - Sofia.

Her professional career began in 1982 as a nurse at the First-Rate District Hospital (nowadays, University Multi-Profile Hospital for Active Treatment in Burgas), at the Internal

Diseases Department: Nursing position occupied from 1982 to 1990.

From 1990 on she occupied a position of Assistant Professor and from June 2020 – of Chief Assistant Professor at Healthcare Department of the Public Health and Healthcare Faculty in the town of Burgas.

Assessment of the quantitative and qualitative indicators

Chief Assistant Katya Eftimova Popova has submitted a signed exhaustive document of prof, containing detailed lists, references, abstracts and full-text copies of the scientific works after acquiring the Chief Assistant Professor position, certificates and degrees, references of citations, a declaration of originality and authenticity of the documents applied to. The submitted materials contain the necessary information for the realization of a quantitative and qualitative assessment of the entire scientific development. The submitted scientific works are in the field of the problems related to the competition: Health protection

and Sports, Professional direction in 7.4. Public Health, Scientific specialty in Social

Medicine and Health Protection and Pharmacy Organization.

A habilitation research work has been submitted thereto: a monograph on B.1 indicator, entitled Geriatric Care – realities and perspectives, Medical-Social Aspects, containing 208 pages, ISBN 978-619-7353-31-0, as well as a monograph entitled Quality of Life, related to Health of People Suffering from Chronic Diseases, ISBN 978-619-7353-32-7. A Declaration of equal participation of other authors have been applied to the co-publications. A reference of the author's articles has been presented where these articles have been totally 29 times cited, together with the publications in which the citations have beexreflected.

The Applicant fulfills the conditions for the occupation of Associate Professor position, in compliance with art.29 of the Act on Development of the Academic Staff in the Republic of Bulgaria and with the minimum of points required for the occupation of Associate Professor position, according to the Regulations on the Implementation of the Act on Development of the Academic Staff in the Republic of Bulgaria in the field 7. Health Protection and Sports, Professional Direction in 7.4. Public Health. In Table 1, I confirm the scientometric values, according to which the Chief Assistant Professor Katya Eftimova Popova fulfills all the conditions for the occupation of the Academic position of Associate Professor, in compliance with art. 73 of the Rules on the conditions and procedure for acquiring science degrees and holding academic positions in *Professor Doctor Asen Zlatarov* University – Burgas and the

minimum points required for.

80 titles and scientific contributions have been indicated in this competition, of which:

- An authored monograph;
- 2. A co-authored monograph;
- 3. Two practical guides of 25% (6 topics) and 20% (2 topics);

4. A co-authored school appliance;

- 39 publications in full text, of which: 7 authored; in 13 ones, the first author; 7 ones
 published in International editions; 3 ones in/English. All the publications are
 scientifically reviewed and indexed.
- 6. Participation in 2 National and 15 International Conferences.

7. Moderator in an International Scientific Conference.

8. Member of Organizational Committees of Students' scientific sessions.

 39 publications have been presented in full text, of which: 7 authored; in 13 – the first author; 7 in International editions; 3 ones in English. All the publications are scientifically reviewed and indexed.

All the published scientific works with which the Applicant has participated in the competition are not overlapped by the publications submitted by the Applicant during the defense of her dissertation work for acquiring of Doctor educational and scientific degree.

Participation in projects. Participation in 19 projects, of which: 1 (one) International and 8 (eight) National ones.

Main directions of the publication activity

The scientific works, submitted by the Applicant, correspond to the requirements by their subject matter and contents, being in the main directions as follows:

 Public health, risk factors for health, health prevention and promotion: health needs; prevention from socially significant disease; children's and pupils' health protection; quality of life of risk groups of population; bioethical aspects in health protection; health education in the communities.

 Healthcare: integrated medical-social care for elderly people, for people suffering from chronic diseases; healthcare organization and management; healthcare quality.

Quality of the medical education: professional preparation of the healthcare specialists, according to the strategies for quality of education and the increased needs of quality on the part of the society.

Lecturer's activity

During the last three academic years, Katya Eftimova Popova, as Assistant Professor, has a workload, as follows: respectively, 781.1, 815.3, 760 classes/yearly. She participates in the teaching of medical-social, obligatory, elective and optional subjects (according to the Unique State Requirements USR) for the acquiring of Professional Bachelor educational qualification degree by students of specialty in Nursing, Obstetrician, Physician Assistant, Bachelor Educational qualification degree. She has the experience in conducting of lectures and practical exercises, seminars, teaching practice and pre-graduate internship. The workload reference covers the requirements provided by the Rules on the conditions and procedure for acquiring science degrees and holding academic positions in *Professor Doctor Asen Zlatarov* University – Burgas.

Conclusion

The examination of the papers submitted by Chief Assistant Professor Katya Eftimova Popova on the competition for occupation of Associate Professor Academic position, has shown that the normative requirements provided by the Act on Development of the Academic Staff in the Republic of Bulgaria, the Regulations on its Implementation and the Rules on the conditions and procedure for acquiring science degrees and holding academic positions in *Professor Doctor Asen Zlatarov* University – Burgas are covered both in the quantitative and qualitative aspects.
