## a. General charecteristics of the scientific production and the publishing activity

Her Author's reference includes more than 77 scientific works, publications, participations in scientific forums and research projects.

She has been participating in this competition with her scientific production of 31 scientific works:

- 1. Two authored monographs;
- 26 full-text publications of which 6 are authored; 10 co-authored where she is the first author; 18 ones published in international editions; 2 ones in English. All the editions are scientifically reviewed and indexed.

• one co-authored school appliance with 50% participations (7 topics);

• one co-authored guide with 25% participation (3 topics);

• online (electronic) course for students of Nursing specialty: a lecturer's online course for the needs of the Philosophy and Introduction of Nursing Care training.
