Dr. Lyubina Racheva Todorova was born in 1967 in the town of Yambol, where she completed her secondary education. In 1991 she graduated medicine at the Higher Medical Institute, Stara Zagora (currently Thracian University, Faculty of Medicine, Stara Zagora). Acquired a specialty in internal medicine in 1997. and clinical hematology in 2000. In 2018 she successfully defended her dissertation on "Pharmacological effects of pain: experimental, clinical and regulatory studies" and obtained a scientific and educational degree "PhD" at MU-Sofia. In the period from 1991-2001 she worked as an intern at the Hospital "St. Panteleimon", Yambol. Since 2001 she has held a number of positions in the Executive

Agency for Medicines - Sofia as: Chief Expert at the Biological Products Directorate; Director of the Transfusion System Control Directorate and Director of the Medicinal Products Authorization Directorate. She has various examinations acquired abroad, such as: IPFA (International Plasma and Fractionation Association) - Viral safety of blood and blood components; US Department of State (International visitors Program) Infectious Diseases and the HIV Pandemic; Paul-Ehrlich Institute, Langen (Hessen), Germany and training in the evaluation of medicinal product dossiers. She speaks English and French. Dr. Lyubina Todorova is a member of the Standing Committee on Medicinal Products of the European Commission (Standing Committee), she is also a member of the Committee for Orphan Medicinal Products of the European Medicines Agency. The candidate is a Member of the Transparency Commission of the Council of Ministers. She has successfully completed a research project in Pharmacology.

Research activity

The total publication activity of the candidate contains 23 scientific papers. The scientific production of Dr. Lyubina Todorova consists of:

-6 publications in indexed editions, in world-famous databases with scientific information (Scopus and Web of Science);

According to the attached reference from the Central Medical Library - Medical University, Sofia, the total number of citations of the candidate so far are 20 Bulgarian citations. The reference in the SCOPUS database contains 137 citations, mostly from a publication that is included as part of the candidate's dissertation work.

2. Pharmacology of the nervous system - in this field the candidate has five scientific

publications

peculiarities of the use of various drugs over 65 years of age
